I understand that my child may be dismissed from the After School
Program after the 3rd late pick up.

Automatic credit card payments will be made using the “Recurring Payment Authorization” form. I understand that payment is due on Monday of each school week and that a late fee of \$15.00 will be charged to my account if payment is not received on that Monday. I further agree and understand that if I am delinquent by more than five (5) days in any payments due to C.E.S., my child may be dismissed from the program at that time.

Care for Kids Assistance:

I understand that if I apply for Care 4 Kids, I am responsible for the full tuition payment until Care 4 Kids support begins. I also understand that if I apply for Care 4 Kids and qualify for assistance, I am responsible for the difference between the amount of Care 4 Kids assistance and the total program fee.
